

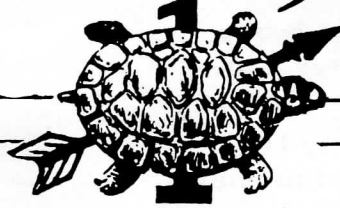

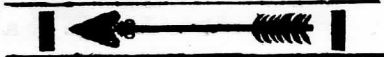
KENNETH O'KEEFE, VICE-CHIEF

MARK CHILUTTI, SECRETARY

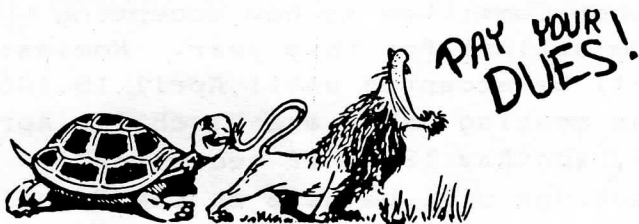

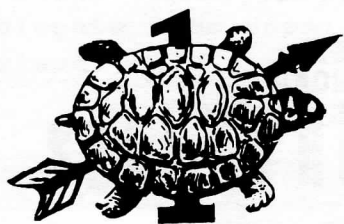
